Attendance Requirements

Summary of the Course

Subject Area: *Music*

Performance Laboratory 2 furthers skills in cooperative musical performance through ensemble study, workshops, and concerts. The course includes participation in a variety of vocal and/or instrumental ensembles. Attendance and participation in Performance Workshop, an opportunity to develop performance skills and knowledge, and Performance Seminar, a forum that provides a platform for open performances and peer criticism, are also course requirements.

At the conclusion of this course the student will be able to

1. Demonstrate developing performance skills in a variety of ensemble and solo performance settings with particular attention to rhythmic precision and tone quality.
2. Illustrate observational and listening skills with developing technical understanding through written and verbal critiques

Teaching Strategies

In order to develop the required technical skills and aesthetic knowledge for ensemble performance, BA Performance Laboratory 2 students are required to study and participate in a range of ensembles (20 hours per session), attend and perform at Concert Practice (8 hours), an open forum that provides public performance experience and the opportunity to develop skill in music criticism (8 hours per session), and participate in performance workshops (8 hours per session), which provide an opportunity to develop performance skills and knowledge.

Assessment Details

Assessment 1: Concert practice

Details: Portfolio of 3-5 equally weighted online critiques or reflections, based on lecture activity. Feedback: Written report on each blog.

Turnitin setting: This is not a Turnitin assignment

Learning outcomes:

- Illustrate observational and listening skills with developing technical understanding through written and verbal critiques

Assessment 2: Ensemble contribution and part-checking

Details: Students' contribution to ensemble rehearsals and performances will be assessed by the ensemble director and through a part-checking test at the end of the session. This is the final assessment task. Feedback: direct during rehearsals and electronic after part-checking.

Turnitin setting: This is not a Turnitin assignment

Learning outcomes:

- Demonstrate developing performance skills in a variety of ensemble and solo performance settings with particular attention to rhythmic precision and tone quality.

Assessment 3: Performance workshop

Details: Students will be required to contribute to class discussion and activities and give a performance for the class with an oral presentation to support it. Length: Up to 10 minutes. Feedback: written report

Turnitin setting: This is not a Turnitin assignment

Learning outcomes:

- Demonstrate developing performance skills in a variety of ensemble and solo performance settings with particular attention to rhythmic precision and tone quality.

Submission of Assessment Tasks

Students are expected to put their names and student numbers on every page of their assignments.

Turnitin Submission

If you encounter a problem when attempting to submit your assignment through Turnitin, please telephone External Support on 9385 3331 or email them on externalteltsupport@unsw.edu.au. Support hours are 8:00am – 10:00pm on weekdays and 9:00am – 5:00pm on weekends (365 days a year). If you are unable to submit your assignment due to a fault with Turnitin you may apply for an extension, but you must retain your ticket number from External Support (along with any other relevant documents) to include as evidence to support your extension application. If you email External Support you will automatically receive a ticket number, but if you telephone you will need to specifically ask for one. Turnitin also provides updates on their system status on Twitter.

Generally in SAM there will no longer be any hard-copy submission; assessments must be submitted electronically via either Turnitin or a Moodle assignment. In instances where this is not possible it will be stated on your course's moodle site with alternative submission details.

Late Assessment Penalties

An assessed task is deemed late if it is submitted after the specified time and date as set out in the course Learning Management System (LMS).

The late penalty is the loss of 5% of the total possible marks for the task for each day or part thereof the work is late. Lateness will include weekends and public holidays. This does not apply to a task that is assessed but no mark is awarded.

Work submitted fourteen days after the due date will be marked and feedback provided but no mark will be recorded. If the work would have received a pass mark but for the lateness and the work is a compulsory course component a student will be deemed to have met that requirement. This does not apply to a task that is assessed but no mark is awarded.

Work submitted twenty-one days after the due date will not be accepted for marking or feedback and will receive no mark or grade. If the assessment task is a compulsory component of the course a student will automatically fail the course.

Special Consideration Applications

You can apply for special consideration when illness or other circumstances interfere with your assessment performance.

Sickness, misadventure or other circumstances beyond your control may:

- * Prevent you from completing a course requirement,
- * Keep you from attending an assessable activity,

Academic Honesty and Plagiarism

Plagiarism is using the words or ideas of others and presenting them as your own. It can take many forms, from deliberate cheating to accidentally copying from a source without acknowledgement.

UNSW groups plagiarism into the following categories:

Copying: using the same or very similar words to the original text or idea without acknowledging the source or using quotation marks. This also applies to images, art and design projects, as well as presentations where someone presents another's ideas or words without credit.

Inappropriate paraphrasing: changing a few words and phrases while mostly retaining the original structure and information without acknowledgement. This also applies in presentations where someone paraphrases another's ideas or words without credit. It also applies to piecing together quotes and paraphrases into a new whole, without referencing and a student's own analysis to bring the material together.

Collusion: working with others but passing off the work as a person's individual work. Collusion also includes providing your work to another student before the due date, or for the purpose of them plagiarising at any time, paying another person to perform an academic task, stealing or acquiring another person's academic work and copying it, offering to complete another person's work or seeking payment for completing academic work.

Inappropriate citation: Citing sources which have not been read, without acknowledging the "secondary" source from which knowledge of them has been obtained.

Duplication ("self-plagiarism"): submitting your own work, in whole or in part, where it has previously been prepared or submitted for another assessment or course at UNSW or another university.

Correct referencing practices;

Paraphrasing, summarising, essay writing and time management

Appropriate use of and attribution for a range of materials including text, images, formulae and concepts.

Individual assistance is available on request from The Learning Centre. Students are also reminded that careful time management is an important part of study and one of the identified causes of plagiarism is poor time management. Students should allow sufficient time for research, drafting and proper referencing of sources in preparing all assessment items.
